MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (here in after called as the 'MOU') is entered into on this the 5th DAY of March, 2025 by and between **Swami Atmanand Govt. English Medium Model College Jagdalpur, Bastar (CG)**, THE FIRST PARTY represented here in by its Name of Competent Authority / Representative AND **Shaheed Mahendra Karma Vishwavidyalaya, Bastar, Jagdalpur (CG)**, THE SECOND PARTY represented here in by its Name of Competent Authority/ Representative

1. Purpose

This MOU is intended to establish a framework for cooperation and collaboration between **SWAMI ATMANAND GOVT. ENGLISH MEDIUM MODEL COLLEGE** and **SHAHEED MAHENDRA KARMA VISHWAVIDYALAYA BASTAR, JAGDALPUR** in various academic, research and institutional development areas. The Parties seek to create a collaborative environment for enhancing educational standards, research capabilities, and professional development.

2. Areas of Collaboration

The Parties agree to collaborate in the following areas:

i. Research and Development:

- Collaborate on joint research projects, seminars, workshops, and conferences in areas of mutual interest.
- Share research resources and findings for the advancement of knowledge in various fields.
- Support the development of research proposals and publications.
- Facilitate the exchange of research staff, graduate students, and scholars to enhance academic collaboration.

ii. Faculty Exchange:

- Develop a framework for the exchange of faculty members for academic and teaching purposes.

- Facilitate the sharing of expertise in various fields through guest lectures, workshops, and seminars.
- Encourage faculty collaboration to improve curriculum and teaching methodologies.
- Organize faculty training and development programs to enhance pedagogical skills.

iii. Laboratory and Infrastructure Sharing:

- Enable the sharing of laboratory facilities, equipment, and technical resources between both institutions.
- Collaborate in the establishment and enhancement of research labs and technical workshops.
- Facilitate student internships, projects, and research activities in labs at both institutions.

iv. Library and Learning Resources:

- Facilitate mutual access to library resources and online databases, ensuring academic staff and students
- have comprehensive access to research materials. Share academic journals, publications, and learning resources.
- Promote inter-library loans and the exchange of academic materials between the institutions.

v. Curriculum Development:

- Collaborate on the development of academic curricula that meet the needs of emerging fields and industries.
- Work together on the design of specialized courses, degrees, diplomas, and certificate programs.

vi. Student Exchange Programs:

- Develop opportunities for student exchange programs for academic learning, cultural enrichment, and exposure to diverse teaching methods.

- Organize joint student activities, field trips, and research projects to foster student engagement and collaboration.

vii. Other Areas of Collaboration:

- Explore other areas of collaboration as mutually agreed upon by both Parties, which may include community outreach, industry partnerships, and other institutional development activities.

3. Duration

This MOU shall be effective for a period of five (5) years, commencing from the date of signing, unless terminated earlier by either Party with a written notice of six (6) months.

4. Funding and Resources

- Each Party shall bear the costs and expenses related to their participation in the activities under this MOU, unless otherwise agreed upon in writing.
- Both Parties may jointly seek funding from external sources such as government bodies, international agencies, or private sectors for collaborative projects and initiatives.

5. Confidentiality

Both Parties agree to maintain confidentiality regarding proprietary or sensitive information shared in the course of the collaboration, unless disclosure is required by law or mutually agreed upon in writing.

6. Intellectual Property

- Any intellectual property developed as a result of this collaboration shall be jointly owned by both Parties unless otherwise mutually agreed upon in writing. Any publication, patent, or other form of intellectual property shall acknowledge the contributions of both institutions.

7. Amendment

This MOU may be amended, modified, or supplemented with the mutual consent of both Parties, provided that such amendments or modifications are made in writing and signed by authorized representatives of both institutions.

8. Termination

Either Party may terminate this MOU by providing six (6) months' prior written notice to the other Party. Upon termination, both Parties agree to complete any ongoing projects or commitments unless otherwise agreed.

9. Dispute Resolution



In case of any dispute arising from the interpretation or implementation of this MOU, both Parties agree to resolve the matter amicably through mutual discussions. If the dispute cannot be resolved through discussions, both Parties agree to submit the matter to mediation or arbitration as agreed upon by both Parties.

10. General Provisions


- The Parties confirm that the terms and conditions of this MOU are in compliance with the legal and regulatory frameworks applicable in India.
- This MOU does not create any binding legal obligations but is intended to set forth the shared goals and intentions of the Parties.
